Polokwane - The Limpopo Department of Transport and Community Safety convened a Strategic Planning session on 19 February 2025 at Bolivia Lodge, in Polokwane led by MEC Violet Mathye. The session brought together Head of Department, Stephen Matjena, Chief Directors, Directors and stakeholders in Public Transport.

MEC Mathye emphasized the importance of tackling critical matters such as community safety, reliable public transport and job creation. She

urged employees to become “enablers of change” within the department and drive service delivery improvements.

“We need to work on the next intake at Traffic College, we have done our spade work and therefore we need to put shoulder to the wheel. The youth are sitting idle while we can channel them into enablers for our 24/7 traffic law. Traffic regulation is amongst our core business and has potential to put us on the map with massive recruitment that can dent the picture of poverty and economic exclusion” said MEC refining job creation matters.

HOD Stephen Matjena presented on departmental overview, focusing on audit outcomes, plans to strengthen crime prevention, and transforming the public service for effective and efficient service delivery.

STRATEGIC OBJECTIVES

The session aimed to finalize the 2025-2030 Strategic Plan and 2025/2026 Annual Performance Plan focusing on improving the department's effectiveness in:

Administration: Reviewing and implementing an ICT plan, digital transformation, refurbishing ICT infrastructure and revamping access control systems.

Transport Operations: Completing the Thohoyandou Intermodal facility, new bus contracts, bus monitoring through technology and clearing the backlog on operating license applications.

Transport Regulation: Implementing e-force gadgets, 24/7 shift systems and sourcing solutions to curb pedestrian deaths.

Provincial Secretariat of Police Services: Utilizing police oversight reports and data to drive impact, engaging stakeholders and implementing crime prevention strategies.

HOD expressed an apprehension on service delivery improvement, ensuring reliable transportation and promote community safety awareness. "It is crucial in driving positive change and achieving the strategic objectives", said HOD

He pleaded with management to reflect on the past departmental performance, aligning the Strategic Plan with various plans and frameworks, such as the National Development Plan (NDP) and Limpopo Development Plan (LDP).
